We apologize for the short notice and regret to inform you the **Americas NavData®** service [**DGAT12**] for your **Garmin GX50, GX55, GX60, GX65, or Model 2101** NMS system can no longer incorporate the entire Americas coverage due to unexpected data processing limitations. Jeppesen and Garmin have exhausted all alternatives and we have no choice but to change the geo-regions for this service.

**Effective Cycle 0911** (Effective Date: October 22, 2009), [**DGAT12**] service will be modified by removing Canada and Alaska from the database. This service will now be branded as **Americas South** and will only include United States, Latin America and South America.

For those of you who need Canada and Alaska coverage, Jeppesen currently offers the **Americas North** service [**DGAT14**], which is comprised of Canada, Alaska, United States, and Latin America.


