It has been identified that certain Passport World Folio 39 chart features, including but not limited to some bridges, floating docks, bottom characteristics, land areas, drying heights, offshore platforms, precautionary areas, depth values, obstructions, and gates, which are important for navigation are not displayed when used with the Nobeltec navigation software packages or Original Equipment Manufacturer (OEM) Marine Plotter solutions listed below:

- Nobeltec Admiral 7.x through 9.3
- Nobeltec VNS 7.x through 9.3
- Nobeltec eChart Mariner 7.x
- Nobeltec eChart Planner
- Northstar 972
- Simrad GB60 v. 1.0 or v1.5

Missing information may represent a hazard if navigators are misusing affected products by relying solely on them for primary navigation, instead of placing primary reliance on up to-date official government charts and Notices to Mariners

This omission will be corrected in the upcoming new edition of Passport World Folio 40 chart library.
